4. Details of our assessment

Introduction:

This is a part review of the Annual 2020 monitoring submissions submitted by the operator in January 2021 (G4).

The operator has also submitted an annual report for the 2020 period.

Comments/Observations:

Air Emission Results for the A1 emission point

- The annual monitoring exercise was undertaken 7th of January 2020 which is within the monitoring period required by the permit (G1).
- The sample was analysed for all four of the emission parameters specified by the permit (G1).
- The report was received within the reporting period specified by the permit (G4).
- From the results submitted all four parameters were below the emission limits specified in the permit (A1).

Air Emission Results for the A2 emission point

- As above,

Air Emission Results for the A3 emission point

- During 2020 the operator reported that the emergency flare operated for less 876 hours over the annual reporting period. As a consequence no monitoring was required over the 2020 period for this emission point.

Water Emission Results for the W1 emission point

- Over the 2020 period the operator reported that no discharges were made over the reporting period from the W1 emission point. Any residual surface water was recovered and reused within the process.

Annual Reporting Parameters

- The operator's submission included the annual production and performance data required by the permit^[1] (covering the 2020 period).

Annual Report 2020

- The January submission also included an annual interpretive report covering 2020. This was submitted within the timeframe specified by the permit (G4).
