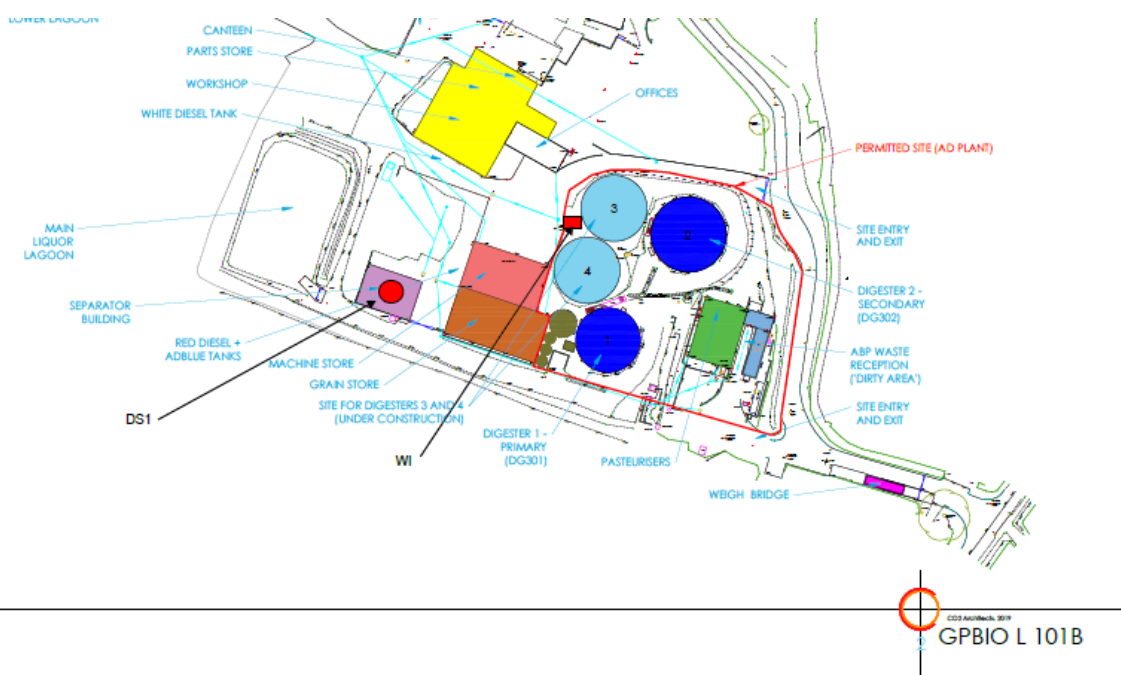
At this time, we do not intend to take any further action.

4. Details of our assessment

A site visit was undertaken on the 4th August 2020 by David Willey representing South East Industry team and Gary Evans from the South West Industry Team.

The purpose of the site visit was to inspect the site for any potential pollution releases and to check whether there have been any incidents on site following a reported pollution at the River Llynfi.



Paul Jones, the Director at the site, walked us around the site providing an overview of the process and an update on the construction work that is being undertaken at the site.

The digesters and associated waste storage areas were inspected and are all located within a large bunded area suitable for the containment of a tank failure. During the time of the inspection there was no evidence of any tank failures on the permitted area. There is work going on at the site for the addition of two new digesters and this has enabled the installation of permeant bunding to be installed. There was no evidence of a breach of the bunding or any spillages within the bunded area.

Any surface water captured within the bunded area is stored and released via a permitted discharge to the River Llynfi following testing. There are two valves that require to be opened before any water is released to the river. At the time of the visit the area was dry due to lack of rainfall.

ACTION: GP Biotec to supply details of any releases via WI during the week commencing 27th July 2020 up until 2nd August 2020?

Operator confirmed no discharge during the above period.

ACTION: GP Biotec to supply NRW with an inventory of chemicals stored and used on site.
