4. Details of our assessment

This was a pre-arranged inspection as NRW officers had to be authorised to access the site.

The site has not been operational for the past thirteen years and the company has not had access to the site during that time.

This inspection was arranged to check the condition of the site as Orchid Shotton Ltd have applied for a permit surrender. The site had been cleared of all waste and associated equipment.

The site is secure as the building is situated within Tata Steel grounds.

All areas of the site appeared in good condition. The inside of the unit is now being used for storage by Tata Steel.

The activities on site, since the permit was granted, included storage of pelletised waste prior to eventual removal from site. There was no waste treatment on site.

The site history has been reviewed and there have been no pollution incidents recorded. I therefore recommend the site for a low-risk permit surrender.
