The purpose of the visit was an introduction tour of the site and to introduce the new site lead for NRW - Daniel Packer.

Site Walkover

As discussed on site, the site has received its last load of waste in August 2023. Capping and remediation works are planned over the next year with target completion date of March 2025.

Construction of the remaining capping shall generally involve:

- Installation of **permanent (Perm) Geological clay liner (GCL) Cap**
- Tie into existing lining system.
- Placement of restoration Soil

At the time of the inspection no malodours or odour like landfill gas were detected at the capped area.

On walk around of the site, the gas compound was passed, and the flare seen operating, Lance Jones confirmed that a new replacement gas engine has been installed and the site is now only using 1 gas engine.

Lance Jones also discussed that the flank of Cell 17 may be built up with soil to reduce the steepness of the slope for stability and to allow access to the plateau upon completion of capping.
