4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised in relation to the Q4 2023 monitoring and waste returns, the bi-annual monitoring returns and annual reports.

Q4 Monitoring Returns - Air

The Q3 monitoring returns were received on 19th October 2023 for emissions from A1, A12 and A13 emission points in compliance with the timescales stipulated in permit condition 4.2.3.

Reported parameters were all in compliance with the emission limit values (ELV's) defined in Schedule 3 table S3.1.

Q4 Monitoring Returns - Water

The Q4 monitoring returns were received on 22nd January 2024 for discharges from W1 emission point in compliance with the timescales stipulated in permit condition 4.2.3.

This was a 'nil' return as no discharges had been made to W1 during this reporting period.

Q4 Waste Returns

The Q4 waste returns were received on 22nd January 2024 for wastes accepted for the quarter September to December 2023 within the timescale stipulated in permit condition 4.2.5.

The waste returns were reviewed and there were no issues identified.

Bi-annual monitoring of emissions

The biannual data was also submitted on 22nd January 2024 in accordance with permit condition 4.2.

Reported parameters were all in compliance with the ELV's defined in Schedule 3 table S3.1.

Environmental Performance Report

The annual performance report was submitted on 31st January 2024 in accordance with

permit condition 4.2.2.

All parameters were reported on as defined in Schedule 4, Tables S4.2 and S4.3. Energy and water usage were comparable to 2023. The total quantity of primary aluminium per tonne manufactured increased slightly from 2022. No issues were identified following the review of the report.
