Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

4. Details of our assessment

Thank you for carrying out a CCTV survey of the outfall pipe from this pumping station and sending on the report to NRW on the 26th of January. (This was as a response to the previous CAR form: CAR_NRW0042957).

Now that the CCTV survey has shown that the outfall pipe from this pumping station is connected to the Afon Goch Amlwch at the duck billed outfall, there are several follow up

questions and actions.

Is there a pipe going out to sea at all from the pumping station? Or did that never exist? Or has it been disconnected or de-commissioned? Or do we even have two discharge points?

As there is a proven link to the duck bill outfall, a permit, or a permit variation will be required to make this legal. Please apply for a permit / permit variation.

The requirement to have a permit in place at the right point has not been scored as a breach **as yet**, whilst you investigate the matter. This will be re-considered if no action taken.
