This CAR form has been raised for the submission of Q1-Q4 2023 waste data.

Waste returns have been submitted for all quarters in 2023 as required by Permit Condition 4.2.5.

The site is post operational and no emissions monitoring have been reported for 2023.

In Q1 2023 1050.9 tonnes of 16 11 03* (other linings and refractories from metallurgical processes containing dangerous substances) were removed from site. No waste was reported as being accepted on site.

Q2, Q3 and Q4 waste returns were all null returns for 2023.
