4. Details of our assessment

This report details the site visit made on the 31 January 2024 to Recresco Limited, permit reference number EPR-DB3797TC. Officer Carla CURTIS attended site at 11:40.

The purpose of the visit was following a report of smoke, burning smell / fuel type odour, within the Springvale area, which was alleged to be coming from Recresco Limited (WIRS Number (2401371).

John MADDOX (Production Manager) accompanied officer CURTIS around the site. Weather conditions were cold and overcast with light drizzle at the time of inspection. Kevin Edwards (Depot Manager) was off site but joined us towards the end of the inspection when he arrived back.

The following observations were made during the site visit.

Recresco has a chimney which lets out steam/vapour from the glass drying process, the steam/vapour is more apparent during chilly days and can look like smoke, there has not been any burning on site and following a thorough inspection of the yard and boundary, no signs of burning were observed.

All processing of glass is undertaken inside the building before being sorted and stockpiled by colour. Maximum storage before processing is 500 tonnes, The product (not waste) is stored outside.

Infrastructure and drainage of the site was inspected, the impermeable surface was in good condition throughout the site. The drains are cleaned on a daily basis.

Technical competency - The Technically Competent Manager (TCM) for the site is John MADDUX, WAMITAB certificate expires 13 April 2024.

Waste Returns submissions - the latest waste return for Q3 2023 was submitted on 8/1/24. Waste codes accepted: 150107 & 191205, totalling 35361 tonnes. 6115.84 tonnes were removed from the site as waste, coded as 191212, 191205. 191203, 191202 & 150107 and sent to landfill sites and glass recycling & Metal Recovery. The permit stipulates a maximum tonnage of waste to be accepted at the site per year at 220,000 tonnes. Please continue to submit quarterly waste returns within one month of the end of each quarter, in line with your permit.

Permit compliance and breaches - No permit non-compliances were identified on this visit and thus no breaches have been scored.
