Waste returns Q4 2023

The Q4 waste returns were received on the 26/01/2024. The site received a total of 691.085, all EWC codes permitted by the permit. The returns are accepted.

PH monitoring probe

All minimum and maximum values for the period July – December were within the permitted range, and the probe was reported to have suffered zero inoperative days for 2023.

Production and treatment data

The site reported receiving a total of 2207.33 tonnes of hazardous waste, with no treatment being conducted on site. Non-hazardous waste inputs totalled 710.26 tonnes.

All reports are accepted.

The operator has confirmed that construction has begun on the Lambyway site, which is expected to be completed by mid-April / early May. Revised FPMP documents as required by preoperational conditions PO1 were received, these will be detailed in a separate CAR issued under the new site permit number (EPR-CB3394CM).
