THE WORKS DESCRIBED BELOW WERE DUE TO BE CARRIED OUT BY MORGAN SINDALL CONSTRUCTION AND INFRASTRUCTURE LTD UNDER LICENCE CML2356 (SEE APPENDIX G). HOWEVER, A CHANGE OF CONTRACTOR TO ALUN GRIFFITHS (CONTRACTORS) LTD REQUIRES A NEW BAND 1 MARINE LICENCE TO BE SOUGHT FROM NRW. NO CHANGE TO THE ACTIVITIES PREVIOUSLY CONSENTED ARE PROPOSED.

THE MANHOLE AND DOWNSTREAM PIPE LOCATED ON THE FORESHORE ADJACENT TO GLANDWR ROAD, BANGOR, LL57 1AD (NGR SH 58530 73020, SEE APPENDIX A – LOCATION PLAN), HAS A HISTORY OF SALTWATER INFILTRATION AS ITS SITS BELOW THE MEAN HIGH WATER SPRINGS. THE PROPOSED WORKS INVOLVE REMOVAL/FILLING IN THE MANHOLE CHAMBER (ALLOWING FOR A PASS THROUGH PIPE) AND RELINE 20M OF DOWNSTREAM PIPE.

THE 20M OF EXISTING PIPE WILL RELINED USING UV CURED-IN-PLACE-PIPE LINING (CIPP) METHODS. ACCESS WILL BE GAINED FROM THE MANHOLE LOCATED IN THE HIGHWAY 20M SOUTH OF THE FORESHORE MANHOLE. NO INTRUSIVE WORKS OR VEHICLE ACCESS TO THE FORESHORE WILL BE REQUIRED FOR THIS STAGE OF THE WORKS. SEE APPENDIX B – PROPOSED WORKS PLAN VIEW, AND APPENDIX C, SECTION 3 – LINING EXISTING 450 SEWER BETWEEN MH 5001 AND MH 5902, OF THE ATTACHED DRAFT METHOD STATEMENT FOR MORE DETAIL.

THE FORESHORE MANHOLE REMOVAL / FILLING WILL COMPRISE OF REMOVING THE METAL MANHOLE COVER AND TOP BRICKWORK LAYERS DOWN TO THE CONCRETE CHAMBER. THE TWO ENDS EXISTING PIPEWORK WILL BE CONNECTED TO PASS THROUGH THE CHAMBER. THE CHAMBER WILL THEN BE FILLED WITH MARINE GRADE CONCRETE AND COVERED TO BLEND INTO THE FORESHORE. THESE WORKS WOULD REQUIRE A SMALL 7 TONNE EXCAVATOR AND DUMPER, WHICH WILL USE AN EXISTING ACCESS ON TO THE FORESHORE. SEE APPENDIX B – PROPOSED WORKS PLAN VIEW, AND APPENDIX C, SECTION 3 - FILL AND ABANDON MH 5001, OF THE ATTACHED DRAFT METHOD STATEMENT FOR MORE DETAIL.
