4. Details of our assessment

Bio-aerosol monitoring

Bio-aerosol monitoring was undertaken in accordance with Condition 3.7.1 (a). The permit requires bioaerosol monitoring to be undertaken twice a year.

Table S3.1 specifies limits for bio-aerosol concentrations as:

- Total bacteria - 1000 cfu/m³
- Aspergillus fumigatus - 500 cfu/m³
- Gram negative - 300 cfu/m³

Results from 3rd November 2023 were received on 2nd January 2024. Bio-aerosol concentrations were compliant at all sampling locations during this monitoring exercise.

Process monitoring was undertaken in accordance with Condition 3.7.1 (b).

Table S3.2 specifies a report must be submitted to NRW detailing the efficiency and effectiveness of the biofilter. This report was received on 15th November 2023 and efficiency was measured at 87.1%.

Waste returns

Condition 4.2.2 requires that waste returns for the previous quarter shall be submitted within one month of the end of the quarter. Waste returns were submitted for all quarters in 2023. Waste returns have been reviewed and no issues found.
