## 4. Details of our assessment

Natural Resources Wales (NRW) Officer Chris BURGE attended The Old Brickworks Limited at Uskvale Park Estate, Pontypool NP4 0HD, at 10:30 on Tuesday 30<sup>th</sup> January 2024 to conduct a planned site inspection of Permit site EPR-HB3433RA. The weather conditions were dry and cloudy at the time of visit. Officer BURGE met with business Director Mr Mark ROBINSON who accompanied Officers around the permitted area.

### Inspection Observations

-

The site was operational at the time of the inspection at limited capacity. There was no processing of waste taking place just customers collecting orders from the site. The operation is well organised and there is clear separation between the waste material and the material that has been through the recovery process and is now classified as a product. Mr ROBINSON explained the rotation process of the waste to ensure it is processed in a timely manner however due to the recent wet weather processing has been slower than normal, but the site is still well within the limits allowed. There were no offensive odours and / or excessive noises witnessed by Officer BURGE during the site inspection.

Mr. ROBINSON explained that the Technically Competent Managers (TCM) Gwyn Jones' new certificate is in date and a copy has been emailed to Officer BURGE.

Photo one shows the screening machine and crusher. Waste material is segregated into various sizes and contaminants are removed. With oversized material then passing through the crusher the crusher has undergone lots of repairs during the winter months which have been challenging but is now operating fully.
