**4. Details of our assessment**

This Compliance Assessment Report follows complaints linked to dust on vehicles in Rectory Lane received on Friday 26<sup>th</sup> January 2024. Dust was evident on inspection of vehicles in the area. **This has been scored a category 3 breach of permit condition 3.2.1 as a result of dust causing a nuisance outside of the site boundary.**

A NRW Officer then met with the Environment & Compliance Manager and the Process & Quality Manager at Knauf Insulations Queensferry facility.

Fibreglass dust was observed blowing around the site adjacent to the Shot Waste bay. The dust suppression system was not being utilised at the time of the visit. The Operator also stated that a road sweeper visited everyday but this was not seen during the visit.

The Operator stated that potentially the offsite dust had been caused by the loading of this waste into a wagon in windy conditions. When the wind blew up the main site road there was clear evidence of fibres in the air. This bay is also not covered. The photograph below highlights the particles in the air and the uncovered waste.

Various other parts of the site were inspected to ensure further dusty activities were not contributing to the off site issue.

**As a result of the dust suppression system not being activated and operations continuing despite inclement weather conditions this has been scored a category 3 breach of permit condition 1.1.1.**

The Operator was in the process of activating the dust suppression system at the end of the visit.

A number of actions were discussed with the Operator to avoid further issues:

- Review procedures linked to the loading of this waste into wagons, including a review of weather conditions at the time of loading.
- Ensure the dust suppression system is utilised in dry conditions, regardless of the season.
- Investigate the possibility of covering the shot waste bay to avoid waste fibre being blown off site.

An update should be provided to NRW by the 23<sup>rd</sup> February 2024.
