4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised by the Natural Resources Wales (NRW) regulating officer, Paul Challender to review the submitted Q3 Monitoring Returns.

Q3 Monitoring Returns

Leachate Levels

Leachate levels are compliant at the monitoring points required by Table S3.1.

Leachate

Six monthly leachate monitoring was conducted in May 2022 as per Permit Condition 3.5.1(a), Schedule 3, Table S3.8 with all required parameters reported. The next round of 6 monthly and annual leachate quality monitoring will normally take place in November 2023.

Surface Water

Monitoring of surface water was carried out as required by Tables S3.3 & S3.9. No data was presented for discharge points WP4 & WP5 as no discharge has occurred at those locations.

Previous issues with knock out pots have been improved by full engagement and inspection of the operator's appointed contractor's work.

Groundwater

Groundwater samples were taken throughout the monitoring period in accordance with Tables S3.4 and S3.10 and the results of the monitoring were submitted as required.

Re-purging of BH12, BH7, BH14 and T13 took place during this quarter and a historic review of site usage has taken place to determine the cause of elevated levels detected in Q2.

Landfill Gas in External Monitoring

Landfills gas in external monitoring boreholes was monitored as per the requirements of Table S3.5. Boreholes T11 is a monitoring point with constantly high CH₄ levels that are known not to be of landfill origin. T11 is in close proximity to T10 and is believed to give rise to interference of recorded gas levels at T10. During this reporting period however, CH₄ did not exceed the 1% v/v CH₄ emission limit value at T10. All other boreholes were compliant for this quarter

Landfill Gas in Waste Monitoring Points

In waste gas parameters were monitored as per table S3.7 and reported as being acted upon across Q3. In this quarter, 155 readings of oxygen levels exceeding 5% were recorded and multiple readings for percentage gas balance being greater than 20%.

CO is recorded as being high at wells W66, W102, W103, W111, W116 & W117.

Notifications

A hotspot was identified at W103 during the quarter. NRW was notified by Schedule 5 submission and further communication by telephone was made after the situation was under control. Steam had been identified and the area was quenched with water. Upon cooling of the area well W103 has been removed and sealed with bentonite to maintain the integrity of the cap. Additional weekly monitoring and investigation is taking place with bag sampling when necessary.
