The Annual Report submitted containing completed tables S4.2 and S4.3 satisfies Permit Condition 4.2.2 and was submitted within the required timeframe.

Improvement conditions

Improvement condition 13 has now been satisfied with the actions as identified on the Fugitive Emissions Risk Assessment WTO-RA03, rev 0 having been completed.

Improvement condition 17. The SF6 system has not been installed. This project has been delayed due to resource availability. The operator expects this system to be operational at the end of Qtr 2, 2024.
