## 4. Details of our assessment

This report details the site visit made on the 24th January 2024 to South West Wood Products, Newport, permit reference number EPR-CB3295FG.

Natural Resources Wales (NRW) Officer Greg GARDNER attended the South West Wood Products site at the Coal Terminal, South Dock, East Way Road, Newport, NP20 2WE for a routine site inspection at 10:30am. The weather was dry, and reasonably mild which it had also been the previous day.

### PERMIT BREACHES / ACTIONS

No permit breaches / actions have been identified during this site inspection.

### GENERAL OBSERVATIONS

The site was not operational at the time of the site inspection. The site is currently non-operational as SWWP Ltd are in the process of transferring their permit to Atlas Commodities which have now acquired the lease to the land. On 11/05/23 a pre-application was requested to apply to change (vary), transfer or surrender an existing activity I.E. Transfer from SWWP Ltd to Atlas Commodities.

From a SWWP Ltd perspective, the housekeeping was in good order with no excessive deposits located on the roads / thoroughfares. Site infrastructure was in good order with no visible defects identified in the surfacing. Although there was some movement of vehicles nearby, noise was not excessive and no evidence of airborne dust was present. There was no excessive odour(s) witnessed by NRW Officer GARDNER. Please note that stockpiles identified in photos 1 and 2 belong to Atlas Commodities and are covered by a number of waste exemptions in place which is covered in a separate exemption CAR form.
