4. Details of our assessment

Natural Resources Wales received a report from Dwr Cymru of a short spill from Pentre Halkyn storm pump station (SPS). An inspection by an operator found a blockage of rags between the wet well and a storage tank. The blockage was stopping some of the sewage flowing to treatment, and caused the storage tank to fill and overflow. Dwr Cymru have supplied a graph that shows telemetry of the wet well. The wet well was full for just under 4 hours, leading to a spill of sewage to the environment. There was a second spill on the graph, this was due to rainfall, so the asset was operating as designed. The nearest rain gauge shows rain during this time.

Dwr Cymru have configured a new alarm to alert of high level in the storage chamber when the wet well level is low. This will alert DCWW of a possible blockage between the storage tank and wet well chamber. All visits to the site are currently postponed as the access is overgrown, grounds maintenance is required. They have said there is no requirement to increase frequency of cleaning following this incident.

This spill is non compliant with the permit, as the spill did not occur due to heavy rainfall or snow melt. This incident has been categorised as a ccs 3 due to the short duration of the spill.
