4. Details of our assessment

This compliance assessment report follows the submission of the Q3 2023 and Q4 2023 monitoring returns, and the 2023 annual performance data.

As detailed in CAR NRW0042311 the HDU and associated infrastructure ceased operation in June 2023 and was removed during Q3 2023. Agreement was made relating to the associated monitoring requirements at that time.

1. Review of quarterly monitoring returns

Emissions to sewer submitted in accordance with Condition 4.2.3:

- July - September - flow readings submitted 10/10/2023
- October - December - flow readings submitted 11/01/2024

Efficacy - as agreed in CAR NRW0042311 efficacy monitoring was not required for Q3 or Q4 2023.

2. Air emissions monitoring

As agreed in CAR NRW0042311 air emissions monitoring was not required for Q3 or Q4 2023.

3. Annual performance reporting

Condition 4.2.2 (a) requires an interpretative review of data to be submitted. As the HDU is no longer operational this requirement has been removed.

Condition 4.2.2 (b) & (c) of the permit requires a report on the performance of the permitted activities over the previous year to be submitted. Annual water, energy, waste and performance parameter data for the HDU was received on the 30 January 2024.

4. Waste returns

Condition 4.2.5 requires that quarterly waste returns for the previous quarter shall be submitted within one month of the end of the reporting period. Waste returns were submitted for 2023.
