Annual report

The Annual Report submitted containing completed reporting forms covering tables S4.2 and S4.3 satisfies Permit Condition 4.2.2 and was submitted within the required timeframe.

Q4 monitoring

Monitoring returns were received on 25/01/23, within the timeframe required by Permit Condition 4.2.3. All monitoring required by Permit Condition 3.5.1 was conducted and reported as per Permit Condition 4.2.3(b). All reported parameters were compliant with specified emission limits levels.
