This Compliance Assessment Report relates to the annual monitoring and reporting requirements in permit no. AP3139FT.

Form Air 1.

Data has been submitted for air monitoring in accordance with permit condition 4.2.

Reported data for emissions points A11 to A12 are within permitted limits.

Please note, an oxides of nitrogen result of 96.51 mg/m³ was reported for emission point A11 and a result of 98.67 mg/m³ was provided for emission point A12. The permitted oxides of nitrogen limit at A11 and A12 is 100 mg/m³, for emission points the reported value is within 10 % of the permitted limit.

Action1: Investigate oxides of nitrogen value at A11 and A12 and provide comment by the 1st March 2024.

Data has not been submitted for emissions points A1 and A2, however, Natural Resources Wales understands that the CHP engines have run for less than 10 % of the time during the reporting period. Therefore, the de-minimis rule applies.

No issues have been identified.
