Data prior to this has been excluded due to reliability issues as it is likely that the monitor had been recording spills when the site was not actually spilling. We have only supplied data from when the new monitor was installed.

Please find the EDM block counted spill data and raw data readings for November 2023 – December 2023 attached. Please see the Comments column (L) for information on data quality issues, corrective action undertaken and data availability."

Please continue to assess the new monitor to ensure it is providing accurate information.

We note issues with the monitor prior to November 2023. If such problems occur in the future, please inform NRW via the OPNOT process.
