4. Details of our assessment

On the 13th of November 2023 NRW officers Harry Warburton, Hannah Jenkins and Alex Grabham attended Llantwit Major WWTW for a routine site inspection of permit BW5103201. Accompanied by DCWW operators MM and RJ.

The weather at the time was strong winds and intermittent heavy showers.

First we were given a site safety induction by MM.

Inlet

First we inspected the inlet which is comprised of a rolling screen that automatically removes RAG, however larger pieces need to be removed manually. there was no evidence of this on the screens.



Aeration tanks

Next we were taken to the aeration tanks, there are three lanes of aeration tanks, where flow is managed by submerged blowers, this is in replacement of old banana arms that was previously used and less effective. All lanes appeared in good working order with adequate surface aeration and no evidence of rising sludge.



Final settlement

There are then two final settlement tanks where sludge is settled to the bottom then recirculated through the aeration tanks, with any excess sludge stored on site then tankered to Cardiff WWTW. There was some duckweed present on the surface of tank 1, however this appeared to have no effect of the quality of treatment. There was no evidence of solids carry over.



UV and final effluent

After the final settlement the effluent is passed through UV disinfection before the final effluent chamber. The chamber is clearly labelled.



Documentation and sample results

The site diary contains daily checks, maintenance and turbidity values. All sample results for 2023 were checked against the permit limits and all were within the parameters. An OPNOT was received on 27/10/23 regarding an MCERTS clean and camera of the line. As well as an OPNOT received 08/08/23 stating there was an issue with a sludge blanket on settlement tanks 1&2.
