THE WATER AUTHORITIES (CONTROL OF DISCHARGES) ORDER 1978

I am directed by the Secretary of State for Wales to refer to the discharge consent in respect of the .MYNTHO..... sewage treatment works dated .1. FEBRUARY... 1964.

The Secretary of State for Wales, having consulted with the Welsh Water Authority, hereby gives notice that in exercise of his powers under Articles 4(8) and 8 of the Water Authorities (Control of Discharges) Order 1978 (SI 1978 No 1210), the conditions imposed on the said consent shall be varied in the following terms:

CONDITIONS

The quality and quantity of effluent shall not exceed the following maximum values:

Biochemical Oxygen Demand (+ ATU) over 5 days at 20°C; ...4.9..... milligrammes per litre.

Suspended Solids dried at 105°C;60..... milligrammes per litre.

Ammoniacal ammonia expressed as nitrogen milligrammes per litre.

Dry Weather Flow ~~litres per second~~ or ...113..... metres cubed per day.

Maximum rate of flow 3.9 litres per second or 339 metres cubed per day.

This variation takes effect from the ...30. January 1985.

Records held on WIMS show MYNYTHO STW - STORM OVERFLOW (CG0030801) to be extant under version 1 issued 30/01/1985 with numeric consent conditions, effective 30/01/1985. The works is currently consented to discharge a max daily volume of 339m³/day effluent to the TRIB. OF AFON SOCH at NGR SH3075029960.

UWWTD directive aims to deliver a standard level of sewage treatment throughout EC member states. This has been interpreted as prescribing a minimum of secondary biological treatment (package plant or equivalent) on all discharges made to a controlled surface water; or a minimum of primary (septic tank or equivalent) treatment on all discharges made to ground.

The discharge of 339m³/day effluent to 'TRIB. OF AFON SOCH', for the purposes of this review, is described as 'secondary treated effluent to surface waters'. This treatment / receiving water combination has been assessed* as APPROPRIATE under the UWWTD review. This consent is reviewed as APPROPRIATE under UWWTD as of 01/09/2005.

* NB, the assessment of this Discharge Consent to meet UWWTD 'appropriate treatment' criteria is based solely on provision of the appropriate 'threshold' level of minimum treatment for the receiving medium. This review does not assess appropriateness in terms of the specific river needs of the receiving water stretch.
