4. Details of our assessment

The purpose of this report is to:

- **assess and record compliance with Condition 3.1.2 (a)(i) relating to Event Duration Monitoring**
- **record our comments and approval of the proposed investigation**
- **give advice on complying with Condition 3.1.2 (a)(ii) going forward.**

Condition 3.1.2 (a)(i) requires that 'if the measured number of block-counted significant spills exceeds the limit specified in Table S3.1 then the operator shall: within 3 months of the trigger breach, submit an initial report to Natural Resources Wales for approval, with reference to the Best Practice Guidance in Schedule 4 Table 4.2, and, where appropriate proposals, including timeframes, for a full investigation into the operation of the overflow including a timetable for the investigation.'

The initial report was due on 30/01/24. As of 13/02/24 we are yet to receive the Initial report meaning you are not compliant with this permit condition. A C4 breach has been recorded for this non-compliance.

This breach is in contravention of Regulation 38 (2) of the Environmental Permitting (England and Wales) Regulations 2016 which states that it is an offence for a person to fail to comply with or to contravene an environmental permit condition.

Please submit an initial report and try to submit any future reports within the required 3-month period.
