### 4. Details of our assessment

NRW received a self report on 11/01/2024 SAP ref 316799242 relating to a spill on 09/01/2024. The self report stated "Retrospective Self Report. Intermittent Spill from Towyn SPS Tidal Tank during times with no PFF to Kinmel Bay SWK." "*Issue now resolved, no further updates to follow.*"

Please provide a response to the following questions by 23/2/2024:

What caused the issue with Pass Forward Flow?  
What was the total duration of spill events from Towyn SPS to sea?  
What will DCWW do to ensure this does not happen again?

The incident was a breach of condition 2.3.1a)i) of the permit and a CCS3 non-compliance has been scored.

NRW will await a response from DCWW and consider it's enforcement response.
