### 4. Details of our assessment

Unannounced site inspection undertaken by Rachel Mallinson, Llyr Samuel and Thomas Anthony, to assess the sites security and that it remains non-operational.

During the inspection, the following observations were made:

#### Site Security

Upon arrival of the site the gates were examined to be unsecured by a padlock however large storage containers block vehicle access to the yard, so it remains secure (See images below).



### **Operations**

Waste storage and treatment operations, as stated in the Environmental Permit, ended over 7 years ago. Records indicate that waste (typically road base and road plannings) has not been accepted on site since October - December 2015.

The site was evidently non-operational. The site was generally clear however some remnants of household waste can still be seen on the yard (See images below).
