## 4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised by the Natural Resources Wales (NRW) regulating officer to review the submitted Q4 monitoring returns covering the period between September – December 2023.

### **Surface Water**

Quarterly monitoring of point source emissions to water was reported as per the requirements of Permit Condition 3.7.1(b), Schedule 3, Table S3.3 and Permit Conditions 4.2.3 (a, b & c), Schedule 4, Table S4.1. All parameters apart from Ammoniacal Nitrogen at P2 were compliant with applied emission limit values (elv).

Ammoniacal Nitrogen was reported to be at 0.27 mg/l. This reported level is within the elv when the 12.7% uncertainty is applied. A Schedule 5 notification was received for this occurrence.

### **In-Field Leachate**

Quarterly monitoring of in-field leachate was reported as per the requirements of Permit Condition 3.7.1(a), Schedule 3, Table S3.1 and Permit Conditions 4.2.3 (a, b & c), Schedule 4, Table S4.1.

RMLP9D was found to be at a level of 15.52 meters. This is a breach of the 1 meter above sump base limit. A completed Schedule 5 notification was received for this breach. There has been ongoing work and maintenance on the leachate system over 2023. Control of leachate levels has broadly improved. This will be further commented upon when the forthcoming annual report is reviewed.

**Score:** (IR2I) Leachate levels. Permit Condition 3.1.2. Score C3

**Action 1:** Continue to improve leachate extraction and management as agreed with NRW under your submitted leachate action plan.

#### **Treated Leachate**

Quarterly monitoring of treated leachate was reported as per the requirements of Permit Condition 3.7.1(b), Schedule 3, Table S3.4 and Permit Conditions 4.2.3 (a, b & c), Schedule 4, Table S4.1.

Priority Hazard Substances screen was reported in the Q4 reporting form as per the requirement for 6 monthly requirements for this screen. The form lists in the Test Method section "Determination of Pesticides in Water by GC-MS etc". It is unknown if this monitoring suite covers the full list of Priority Hazard Substances.

**Score:** (IR3E) Monitoring. Permit Condition 3.7.1(b), Schedule 3, Table S3.4. Action Only.

**Action 2:** Confirm in the submission of the annual report the determinands monitored in the reported Priority Hazardous Substances screen by 29/02/24.

#### **Groundwater**

Quarterly monitoring of groundwater was reported as per the requirements of Permit Condition 3.7.1(c), Schedule 3, Table S3.5 & S3.10 and Permit Conditions 4.2.3 (a, b & c), Schedule 4, Table S4.1.

Table 3.5 requires the monitoring of Mecoprop and applies an elv of 0.018 mg/l. The elv column in the supplied monitoring data states an elv of 0.0001 mg/l. Mecoprop has been monitored and complies with the permitted elv however, the statement of an incorrect elv has the potential for the operator to erroneously believe that they are in compliance.

**Score:** (IR3E) Monitoring. Permit Condition 3.7.1(c), Schedule 3, Table S3.5. Action Only.

**Action 3:** Ensure that the elv is correctly listed in monitoring returns and that the operator has regard for the correct elv for maintaining compliance.

#### **Landfill Gas in external monitoring boreholes**

Monthly monitoring of landfill gas in external monitoring boreholes was reported quarterly as per the requirements of Permit Condition 3.7.1(d), Schedule 3, Table S3.6 and Permit Conditions 4.2.3 (a, b & c), Schedule 4, Table S4.1. The issues identified are discussed below.

CH<sub>4</sub> breached the 1%v/v elv at borehole G12 with a recorded value of 84.7%v/v. CO<sub>2</sub> breached the 1.5%v/v elv at borehole G22 with a recorded value of 28.4%v/v. Breaches of this size are consistently recorded across quarters and the landfill requires investigation and works to control migrating gas. The operator has engaged with a consultant to investigate these issues, identify sources, and increase gas control. Notifications were submitted.

CH<sub>4</sub> at 84.7%v/v has generated a score.

**Score:** (IR3A) Emissions to water, air or land. Permit Condition 3.1.7(d), Schedule 3, Table S3.6. Score C3.

**Action 4:** Gas migration investigation report is in progress with appointed consultants.

CO<sub>2</sub> at 28.4%v/v has generated a score:

**Particulate matter in ambient air**

Particulates were monitored and reported as per the requirements of Permit Condition 3.7.1(e), Schedule 3, Table S3.11 and Permit Conditions 4.2.3 (a, b & c), Schedule 4, Table S4.1. All parameters for all required monitoring points were reported as compliant.
