4. Details of our assessment

Waste and Industry Officer; Gareth Morris attended site on the 30th of June 2023, to complete a routine site inspection. The weather was mild and dry at the time of the site inspection. Thank you to, Simon Watkins, Contracts Manager for taking the time to show me around the site. In general, the site appeared well managed at the time of the inspection and no breaches against your permit were recorded while on site.

After introductions on site, Mr Watkins informed me that the site had been mothballed and had not been in operation or accepted any waste since October 2017. Mr Watkins showed me around

the mothballed site, and everything looked in order , and the site has been returned back to its original state. Please see photographs 1,2,3 & 4.

Mr Watkins stated that the land had been sold for housing and that Tarmac were awaiting formal planning to be granted by the local authority. The planning application is in the final stages. Once the planning application has been approved Tarmac will then formally start the process of surrendering the permit they hold.
