## 4. Details of our assessment

This Compliance Assessment Report (CAR) has been raised by the Natural Resources Wales (NRW) regulating officer to review the submitted Q3 monitoring returns covering the period between July - September 2023. The Q3 returns were received by email on 28/10/23 in compliance with Permit Condition 4.2.3.

### **Surface Water**

Quarterly monitoring of point source emissions to water was reported as per the requirements of Permit Condition 3.7.1(b), Schedule 3, Table S3.3 and Permit Conditions 4.2.3 (a, b & c), Schedule 4, Table S4.1. All parameters apart from BOD at P1 were compliant with applied emission limit values (elvs).

BOD was reported to be at 30 mg/l. This is above the 20 mg/l elv and has attracted a score. The operator did

not submit a Schedule 5 notification for this breach, and this has attracted a score.

**Score:** IR3A - Emissions to water, air or land. Permit Condition 3.1.2, Schedule 3, Table 3.3. Score C3.

**Action 1:** Ensure proactive control of monitored parameters to comply with elvs.

**Score:** IR4C – Notification. Permit Condition 4.3.2. Score C3.

**Action 2:** Ensure Schedule 5 notifications are submitted in relation to identified permit breaches.

#### **In-Field Leachate**

Quarterly monitoring of in-field leachate was reported as per the requirements of Permit Condition 3.7.1(a), Schedule 3, Table S3.1 and Permit Conditions 4.2.3 (a, b & c), Schedule 4, Table S4.1.

LCP2 was found to be at a level of 3.1 meters. This is a breach of the 1 meter above sump base limit. A completed Schedule 5 notification was received for this breach highlighting that a problematic pump had been identified and replaced, returning leachate heads to compliant levels.

**Score:** (IR2I) Leachate levels. Permit Condition 3.1.2. Score C3

**Action 3:** Continue to improve leachate extraction and management as agreed with NRW under your submitted leachate action plan.

#### **Treated Leachate**

Quarterly monitoring of treated leachate was reported as per the requirements of Permit Condition 3.7.1(b), Schedule 3, Table S3.4 and Permit Conditions 4.2.3 (a, b & c), Schedule 4, Table S4.1.

Ammoniacal Nitrogen was reported at 169 mg/l against an elv of 150 mg/l however, once the uncertainty of 12.7% is taken into account this does not represent a breach of the elv. The operator highlighted the high level in a completed Part A & B notification. Levels for this parameter are reported to have significantly improved since the installation of a new DAF unit.

Priority Hazard Substances screen was reported in the Q2 reporting form as per the requirement for 6 monthly requirements for this screen. The form lists in the Test Method section "Determination of TPH in Water by GC-MS". TPH is a parameter for Total Petroleum Hydrocarbons. The Priority Hazard Substances screen comprises a different set of chemicals. NRW applied an action, Action 2 in CAR\_NRW0042575-Q2 Monitoring Returns, requiring confirmation on whether a Priority Hazardous Substances screen was conducted in Q2. This action has not been complied with and no confirmation of this suite of parameters being conducted or the results have been received.

**Score:** (IR3E) Monitoring. Permit Condition 3.7.1(b), Schedule 3, Table S3.4. Score C3.

**Action 4:** Review and update monitoring procedures to ensure that all parameters are monitored as per permit conditions. Submit updated procedure to NRW by 02/04/24.

#### **Groundwater**

Quarterly monitoring of groundwater was reported as per the requirements of Permit Condition 3.7.1(c), Schedule 3, Table S3.5 & S3.10 and Permit Conditions 4.2.3 (a, b & c), Schedule 4, Table S4.1.

#### **Landfill Gas in external monitoring boreholes**

Monthly monitoring of landfill gas in external monitoring boreholes was reported quarterly as per the requirements of Permit Condition 3.7.1(d), Schedule 3, Table S3.6 and Permit Conditions 4.2.3 (a, b & c),

Schedule 4, Table S4.1. The issues identified are discussed below.

CH<sub>4</sub> breached the 1%v/v elv at borehole G12 with a recorded value of 82.8%v/v. CO<sub>2</sub> breached the 1.5%v/v elv at borehole G24 with a recorded value of 34.0%v/v. Breaches of this size are consistently recorded across quarters and the landfill requires investigation and works to control migrating gas. The operator has engaged with a consultant to investigate these issues, identify sources, and increase gas control. Notifications were submitted.

CH<sub>4</sub> at 88.2%v/v has generated a score.

**Score:** (IR3A) Emissions to water, air or land. Permit Condition 3.1.7(d), Schedule 3, Table S3.6. Score C3.

**Action 5:** Gas migration investigation report is in progress with appointed consultants.

CO<sub>2</sub> at 34.0%v/v has generated a score:

**Score:** (IR3A) Emissions to water, air or land. Permit Condition 3.1.7(d), Schedule 3, Table S3.6. Score C3.

**Action 6:** Gas migration investigation report is in progress with appointed consultants.

**Particulate matter in ambient air**

Particulates were monitored and reported as per the requirements of Permit Condition 3.7.1(e), Schedule 3, Table S3.11 and Permit Conditions 4.2.3 (a, b & c), Schedule 4, Table S4.1. All parameters for all required monitoring points were reported as compliant.
