4. Details of our assessment

A routine site inspection was undertaken on Wednesday 7th February 2024. Present at the time of the inspection were David Morgan (Natural Resources Wales) and Stuart Hanford (Director, Derwen).

The primary aim of the inspection was to assess compliance in relation to waste acceptance, storage and treatment practices.

During the inspection, the following observations were made:

Waste Acceptance

An inspection of the main waste reception area was undertaken. While on site, a load was accepted and the process for accepting waste was reviewed. We discussed the need for operatives to visually inspect the loads and undertaken initial assessments of waste.

We discussed the process for quarantining and rejecting loads that did not conform to the list of acceptable wastes as described in the Environmental Permit.

At the time of the inspection, all waste appeared to comply with the list of waste in the Environmental Permit. The main waste storage area, where waste is stored prior to further treatment (sorting etc.), was free from Waste Electrical and Electronic Equipment (WEEE) items. As you are aware, there has been an increase in incidents of fires at waste sites related to WEEE items in general waste so it is encouraging to see efforts being made to remove these items from general waste prior to further treatment.

Waste Storage (outside yard)

All waste that was stored outside at the time of the inspection was stored under cover. This prevents rain-water contaminating surface water run-off.

Generally, the outside yard appeared to be well maintained. There was very little or no windblown litter on site and site drains were clear and free from debris. General housekeeping in this area is of a high standard.

On site, we discussed the potential expansion of the operational area in the outside yard. It was acknowledged that necessary infrastructure improvements would need to be made to this area, notably the installation of impermeable surfaces where there is currently unmade ground.

Site Boundary

It was noted that you intend to install fencing at the boundary of the yard next to the river. Although unauthorised access to the site from this area is unlikely, a boundary fence would help prevent any such unauthorised access and it would also help prevent the escape of litter from site.

At the time of the inspection, there was no evidence of litter/waste escaping site in this area.

Summary

No non-compliances were recoded during the inspection. Operations were not perceived to be having a detrimental impact on the environment and operations were not assessed as being in contravention of the Environmental Permit.

Waste acceptance, storage and treatment practices were observed and a discussion was held regarding the procedure for managing the quarantining of waste on site.

To the rear of the site, next to the river, there was no evidence of litter/waste escaping site.

Next Inspection

It is likely that in the next inspection Natural Resources Wales will assess the following areas of compliance:

- * Duty of Care Waste Transfer Notes (including focus on Transfrontier Shipment of Waste)
- * Noise Mitigation
- * Accident & Emergency Plans (including fires)
