This Compliance Assessment Report has been raised to comment upon the status of this permit and the submitted waste returns for 2023.

The operator maintains that this Standard Rules composting permit is not in use. This is

reflected in the nil returns received in compliance with Permit Condition 4.2.2.

Natural Resources Wales reminds the operator that this permit although not in use will still require the payment of subsistence fees annually. The operator may wish to surrender this permit to remove the requirement to pay this annual fee and submit nil returns. The operator should engage with their regulating officers on how to proceed if they decide to surrender the permit.
