4. Details of our assessment

This was a routine announced compliance visit carried out by Malcolm Dines, who met with Bill and Jim Lloyd- owners and Technically Competent Managers for the site - after you notified Natural Resources Wales (NRW) that you were now accepting wastes as a feedstock and therefore need to operate in accordance with your Environmental Permit.

The weather was dry and overcast.

At the start of the visit you questioned whether the material you were accepting was actually waste. While reviewing documentation at the site, you questioned whether you were using the correct EWC code on the waste returns. When pointed out that the EWC code should be included on the Waste Transfer Notes provided with the delivery of the waste, the note you showed did not include an EWC code that is required for compliance with the Waste Duty of Care. When I subsequently contacted the haulier to discuss this matter they stated that it was because the document was a delivery note and the material was not a waste. They then provided documentation from Volac Ltd., the producer of the material, that shows that they describe the material as a product.

Article 5 of the Waste Framework Directive covers By-products

These are set out as being, *"A substance or object, resulting from a production process, the primary aim of which is not the production of that item"* The material supplied to you by Volac clearly falls into this category.

Article 5 continues by stating the conditions that must be met in order for that material to be regarded as not being waste:

- (a) further use of the substance or object is certain;*
- (b) the substance or object can be used directly without any further processing other than normal industrial practice;*
- (c) the substance or object is produced as an integral part of a production process; and*
- (d) further use is lawful, i.e. the substance or object fulfils all relevant product, environmental and health protection requirements for the specific use and will not lead to overall adverse environmental or human health impacts*

At present NRW consider that these specific requirements are being met, so allowing this material to be considered a by-product and not a waste. Therefore your Anaerobic Digestion (AD) facility is not subject to regulation by NRW under this permit. It also means that the digestate you produce from the AD site is not waste and does not need to be spread under a deployment.

Please note that NRW's position regarding the by-product may be subject to change. It is the responsibility for the producer to accurately describe the material and if at any time, it is shown that this material does not meet the test for being a by-product it may result in being classed as a waste.

In this document 'Natural Resources Wales' means the Natural Resources Body for Wales established by Article 3 of the Natural Resources Body for Wales (Establishment) Order 2012
