### 4. Details of our assessment

This Compliance Assessment Report (CAR) has been generated by the Natural Resources Wales (NRW) regulating officer to comment on the 2023 Annual Report.

The annual report was submitted on 11/01/2024 in accordance with Condition 4.2.1 of the Permit.

Performance Indicators have been recorded for the period 01/01/2023 to 31/12/2023 and are as follows:

- Production Man Hours decreased by approximately 13.4% on 2022, to 77,587 hours.
- Electricity usage is 2,025,110 per kWh, this is lower than 2022 but reflects the decrease in production man hours.
- Gas usage is 67,652m<sup>3</sup> this is approximately 77% of the usage recorded in 2022.
- 451 tonnes of waste was produced, which equates to 0.0058 tonnes of waste per production man hour, this is a slight increase on 2022. The waste figure includes off-site disposal of approximately 278 tonnes of wastewater by tanker and the dismantled air gantry machine which comprised approx. 90tonnes of scrap steel. Cardboard and plastic wrapping both now captured into the specific waste stream bailer. The Operator is in the process of acquiring separate waste stream bins prior to the implementation of the Workplace Recycling Regulations in April 2024.
- Water usage for 2023, is recorded as 1,221m<sup>3</sup>, (0.015m<sup>3</sup> per production man hour).
- There has been no contamination or decontamination of the site in the year.
