4. Details of our assessment

This Compliance Assessment Report (CAR) has been generated by Natural Resources Wales (NRW) regulating officer to comment upon the Annual Report and Q4 Monitoring Returns.

1. Q4 Monitoring Returns

Q4 2023 (October - December) monitoring results were submitted to NRW on 02/01/24 in accordance with Condition 4.2.3.

1.1 Emissions to Water - Emission Point W1

Emissions to water for Q4 were tested on the 12/10/2023, 28/11/2023 and 19/12/2023. All parameters were within the emission limit values (ELVs) defined in the Permit (S3.2).

2. Annual Report

The Annual Report was submitted to NRW via email on 30/01/23 as required by Permit Condition 4.2.2. The Annual Report provided all the information as required under the Permit.

2.1 Annual Production

Annual production for 2023 (767,553 units) is similar to the previous year (770,484 units).

2.2 Performance Parameters.

A summary of performance parameters is as follows:

No non-hazardous waste production is reported for 2023. NRW has previously been informed by the Operator that non-hazardous waste is generated by the facility and is sent to an energy from waste facility. The Operator is required to record and report waste production. ***This is a breach of Condition 4.1 and 4.2 and has been scored C4.*** The

absence of non-hazardous waste records also reflects a failure to implement and /or keep up to date the management systems. ***This is a breach of Condition 1.1 and has been scored C4.***

Hazardous waste generated is similar to 2022 levels.

Water usage is slightly lower (62,136m³) than 2022 (66,645m³). Energy use and CO₂ production are similar to 2022.

All other reported parameter contained the expected data, with no apparent issues.

3. Actions.

Action 1. Review and update waste recording and reporting procedure and provide NRW with the waste produced at the Facility in 2023, **by 29 February 2024.**

Action 2. Revisit the management system procedures for recording waste and identify the root cause for the absence of non-hazardous waste records. Provide NRW with a summary of the findings and a copy of the relevant procedure **by 15 March 2024.**
