4. Details of our assessment

Natural Resources Wales (NRW) Officers Chris BURGE, Gavin DODD and Alastair KRZYZOSIAK attended Thomas Waste Management Limited to complete a routine, unplanned compliance inspection of the permit EPR-AP3399FR. The weather at the time of the inspection was heavy rain and wind. Officers met with site manager Gareth THOMAS.

Inspection Observations

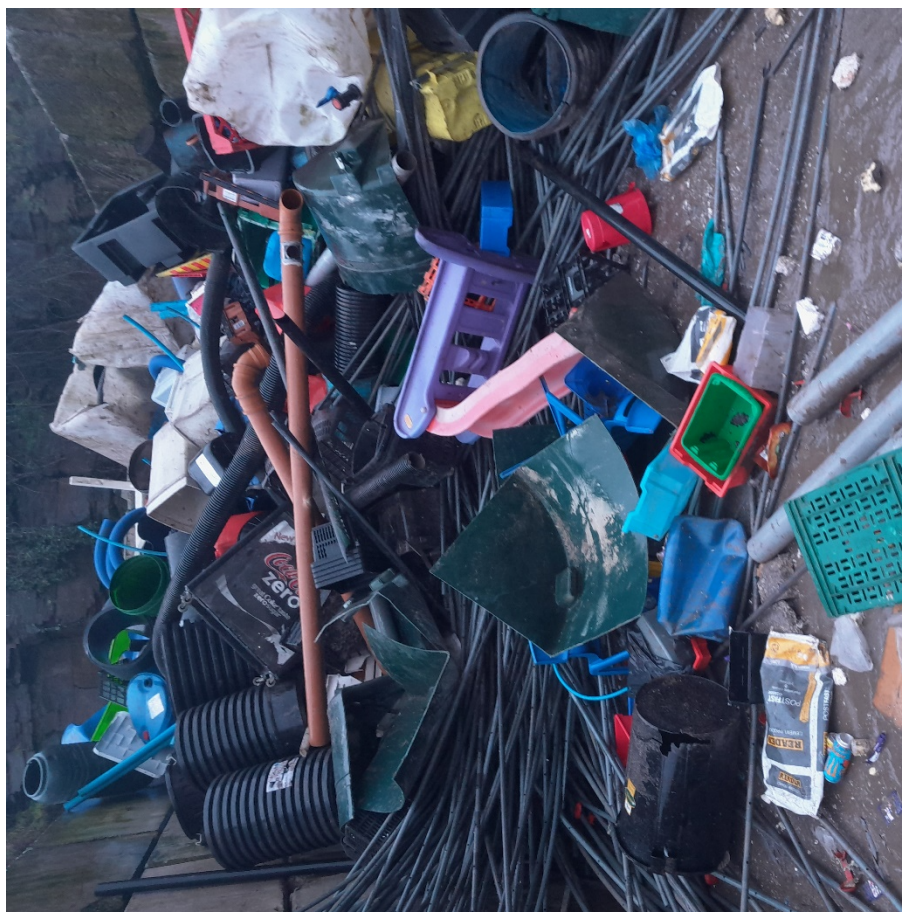

The site was operational at the time of the inspection. The weather conditions during the inspection were poor however the site was still in a good condition with regards to housekeeping and deposits on road. All waste types were stored and segregated appropriately within concrete bays or sealed skips within the permitted area awaiting removal to other sites. There was no waste(s) stored outside the permitted boundary during the site inspection. Mr. Thomas explained he removes 4 loads a day from the site to other facilities for the waste to be recycled and / or for permanent disposal. 75% of all waste at Thomas waste is sent for recycling. There were no offensive odours and / or excessive noise witnessed by NRW Officers during the site inspection. Site security was checked with no concerns identified.
