We can see that you have recorded Stephen Vickers as the sites technically competent manager (TCM) on the previously submitted waste returns.

We are unable to locate a certificate for them on our system and in which case we are requesting the original certificate along with any continuing competence to be submitted to NRW. If this person is no longer the sites TCM please provide copies of who has replaced them.
