4. Details of our assessment

On 18th January 2024 a compliance audit sample was taken at the site. Following analysis, the BOD and Suspended Solids concentration were found to be in breach of parameter limits.

The BOD (Biochemical Oxygen Demand) result was 181 milligrams per litre of a parameter of 20 milligrams per litre.

The Suspended Solids result was 51 milligrams per litre of a parameter of 30 milligrams per litre.

On review of the results of previous routine samples taken on 13th February 2023, it was noted that the BOD concentration was 122 milligrams per litre and Suspended Solids concentration was 38 milligrams per litre. This again was a breach of your licence condition and further indication to improve operations.

Action 1:

Consider additional measures / investigations undertaken e.g. installing an upstream screen to protect the plant from wet wipes.

Action 2:

Provide maintenance schedules, frequent checks and monitoring records.

Action 3:

Provide desludging records and any records of remedial parts purchased / changed for the plant.

Other considerations:

Rewriting to residents.
