Introduction

This Compliance Assessment Report (CAR) is an assessment of the annual submission for Pwllfawatkin Landfill, which was provided by FCC Environment (the Operator) covering the 2023 period.

2023 Annual Submission

The *Pwllfawatkin Annual Monitoring Report*, which is pertinent to permit condition 4.2.2a was submitted by the operator on the 16th of February 2024. NRW have not compliance assessed this report. In addition, the Operator submitted their surface emissions survey report, which is conducted via usage of a flame ionisation detector (FID). The Operator reported the following statement within the aforementioned report:

'No elevated readings were detected during the survey of the 50m and 25m surface transects. In addition, no elevated readings above 100ppm were detected during the survey of the gas and leachate infrastructure.'

The *Pwllfawatkin Landfill Site Annual Performance Report Jan 23 – Dec 23* was submitted by the Operator on the 26th of January 2024, which was within the timeframe (by the 31st of January 2024) specified by permit condition 4.2.2. The submitted document included information that fulfilled requirements outlined by permit conditions 4.2.2b to 4.2.2h.

The Operator submitted monitoring data regarding emissions testing from the Flare and Gas Utilisation Engine 3 located within the gas compound, which was completed on the 22nd of March 2023. It has been noted that the average recorded results were all below the permitted emission value and thus **compliant** with permit condition 3.1.1.
