This Compliance Assessment Report (CAR) has been issued in response to the submission of the 2023 annual monitoring returns by MicroPharm Ltd (the operator) for activities at Cnwcau Pharmaceutical Plant - Cnwcau, Cilgerran, SA43 2SN under permit EPR-CB3092CA.

This CAR was undertaken on 15 February 2024. However, to ensure that the CCS score is attributed to the correct financial year (for billing) the date on CARS has been altered to 31 December 2023. There are no parameters for emission that are subject to permit, so this CAR is in relation to the submission of annual reporting as per permit condition 4.2.1. This was received 7 February 2024 and was in compliance with the permit requirements
