Introduction

This Compliance Assessment Report (CAR) is an assessment of the annual submission provided by Novera/Infinis Energy (the Operator), which covers the 2023 annual period.

2023 Annual Submission

The reporting form (referenced PI1) was submitted by the Operator on the 12th of January 2024, the form detailed informative requirements (Schedule 4: Tables S4.1 and S4.2) set out by NRW within permit condition 4.1.3.

The information was submitted within the specified reporting period (by the 31st of January), which is **compliant** with permit condition 4.1.3.

Following assessment of the annual report, the subsequent observations were noted:

- Performance Indicators:
 - 2258MWh Total Production.

- 2053MWh Exported
- Estimated 8128.8kg NO₂ produced in 2023.
- Estimated 23,031.6kg CO produced in 2023.
- Volume of Landfill Gas treated 1,562,880m³
- Gas Plant downtime: 9.6%

The Operator submitted a Schedule 6 Notification on the 23rd of May 2023 regarding the release of an unknown quantity of Landfill Gas, which followed an outage of the Gas Utilisation Plant (GUP). It has been determined by NRW that the breach falls under the remit of an alternative permit (CP3735PB), and as a result will not be discussed within this CAR.
