The site will continue to monitor emissions from the stacks even though it is not required by the permit as a from of process control.

Performance 1

Annual production has not been submitted for 2018 as the site has been operating in sampling mode for their customers.

Waster and energy usage as been received as required by Table S4.3 of the permit.
