The site used 1,976m³ of water in 2023. This is an increase of 2.5% from the previous year.

Waste Disposal & Recovery (R1)

Total amount of waste produced in 2023 was 152.01 Tonnes. Of this 148.41 Tonnes was hazardous waste and 3.6 Tonnes was non-hazardous waste. Of the non-haz waste, 5537kg was sent to a waste to energy plant, 2784kg was recycled and 900kg was sent to landfill.
