4. Details of our assessment

NRW Officers BA and GH met with John (HSE Manager) and Nathan (Utilities Engineer) on 31 January 2024.

Initial discussion of changes since previous visit. John advised of Nathan recently joining as Utilities Manager and new EHS Coordinator to start soon. We advised of upcoming deadlines for annual report and emissions monitoring results.

Site tour undertaken to familiarise BA with site.

Recent changes have included a new H₂O tank installed due water pressure issues at night. Waste contract currently out to tender.

A contaminated batch of Caustic has caused a 4 tonne block in tank system, which is being cleared by the supplier, who will be disposing of the waste.

Issue: Interceptor not installed. Awaiting drainage plan with recommendations for improvements before new containment plan can be decided on. Drainage plan expected imminently.

Action: Drain survey report to be sent to NRW when received.

No other issues found whilst

John advised of future improvements that are planned:

- Forklift fleet to go 100% electric in Summer 2024
- Solar panels to be installed Spring 2024
- Princes are part of a SWIC pilot project, boilers to be changed to H2 in 2025.
