4. Details of our assessment

On Thursday 11th January 2024 Natural Resources Wales officers attended site.

This was a routine site inspection for permit ref EPR/FB3734RP which was carried out by

Waste Regulation Officer Ian Thomas and Waste Crime Officer Eleanor Pierce.

On arrival at site, officers met with Steve Amos, Operations Manager for the site. Mr Amos explained that the owner, Paul Dromgoole was on leave and the technical competent manager, Martin Womack was not on site that day.

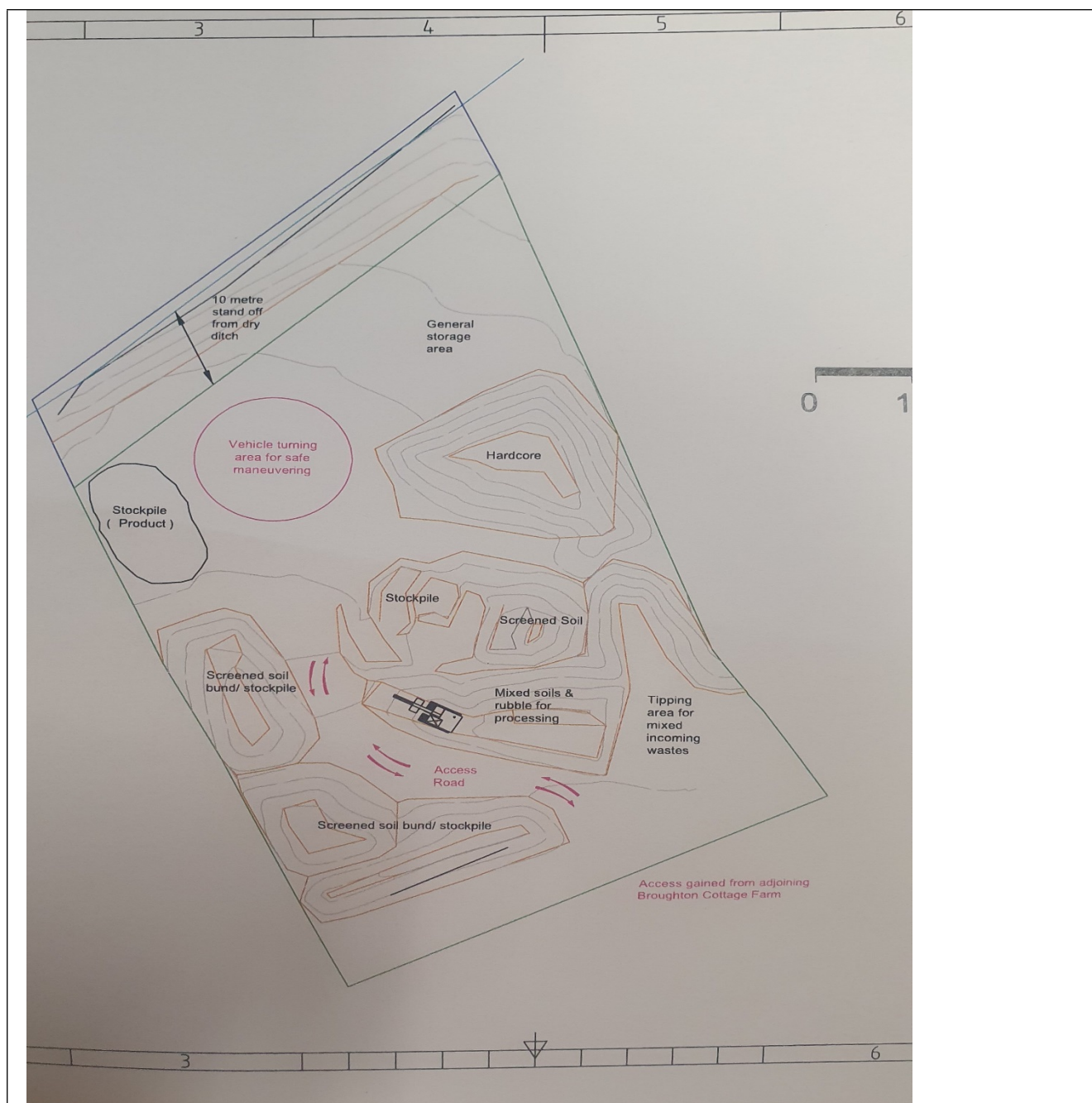
Mr Amos explained the how the operation was being carried out and had put in systems to ensure waste returns were completed as required and how waste storage totals are managed.

The site has limited access and has security systems and cameras covering the area.

Officers completed a walk around the site unaccompanied, noting where waste is brought in via tipper vehicles, some of the inert waste being treated, and some 6F2 product stored.



Following health and safety guidance, officers could not fully view the opposite side of this area which is located near to the boundary labelled 'hardcore'. The view although limited, looked like waste has spread over and outside if the permit boundary. This can be seen from the A55 carriageway.

All waste must be stored within the permit boundary. Referenced in EMS 2.8.1 All waste operations will take place within the areas shown on Drawing No. PMD/002/A

Waste stored outside of the permit boundary would be a breach of the permit and could attract enforcement action. All operations must take place within the permit boundary. This is recorded as an **Action Only**, and will be reviewed on the next site visit.

On return to the site office, Waste Transfer Notes were viewed, all relevant paperwork was available and looked to be in order.
