### 4. Details of our assessment

On 17 January 2024 a site inspection was undertaken by Sally Wakeford and Katie Lewis-

davies of Natural Resources Wales. We were accompanied on site by Rachel Thomas of Pembrokeshire County Council.

The site is secured with a field gate, with no evidence of unauthorised access. The area is mostly grassed, although very soft underfoot. The southern edge of the waste deposit is covered in bramble.

### **Permit:**

The current permit is still the October 1991 Waste Disposal licence WD/056. There has been no variation completed for the closure of the landfill. However, when the Landfill Regulations came into force the site could no longer accept waste and was put into closure.

### **Working Plan:**

**ACTION: Please provide a current working plan for the site. The working plan should reflect the closure status of the site.**

The working plan we have on file from 2000 does not contain all the pages. If you have a better copy of this or a newer working plan please provide this.

### **Surrender:**

In 1998 a surrender application was refused due to lack of evidence the site is not likely to cause pollution, and samples had shown elevated levels of methane and Fe/Me rich leachate entering the water course along the side of the site.

Due to the strata underlying the site there is potential for groundwater to be impacted from the landfill leachate, if it is producing any.

### **Sampling and Monitoring**

There are no requirements in the permit to undertake routine monitoring of groundwater, surface water or landfill gas. However due to the missing pages of the working plan we are unable to ascertain if the working plan required any monitoring.

Some monitoring will be required for the eventual surrender of the permit, to provide evidence the landfill is not impacting the surrounding area.

Suggested course of action:

- Some water sampling of the nearby watercourses to understand if the landfill is producing leachate as it was previously producing high levels of Fe and Mn into the surface water.
- Walkover gas survey (e.g. Gazomat survey) to understand if any methane is being produced by the site.
