## 4. Details of our assessment

This compliance report details the site inspection conducted by Natural Resources Wales (NRW) officer on 7 February 2024 at Roydon Bottle Recycling Ltd, Blackwood Business Park NP12 2XN- Permit number EPR-PB3393HD Officer Carla CURTIS attended Roydon Bottle Recycling Ltd at 11:30 to conduct a routine inspection. Site Manager Phillip HOPKINS accompanied NRW officer around the permitted area. Weather conditions were cold and overcast at the time of inspection.

On the last site inspection October 2022, the site had halted operations and was in the process of conducting maintenance work on machinery and resurfacing the factory floor this resulted in a significant build-up of sludge material as the de-watering screw was not operating to full capacity. This caused the paper sludge to retain a higher water content than usual. Water was soaking out of material and pooling around machinery and walkways in the area. I was pleased to see this was all working fine on this visit, there were no issues.

On inspecting the grounds outside it was good to see that the filters on the drains were not as congested as the last visit, they are now checked daily and then deep cleaned weekly. It was good to see this improvement. Please continue to ensure that the drains are kept clear from debris and litter.

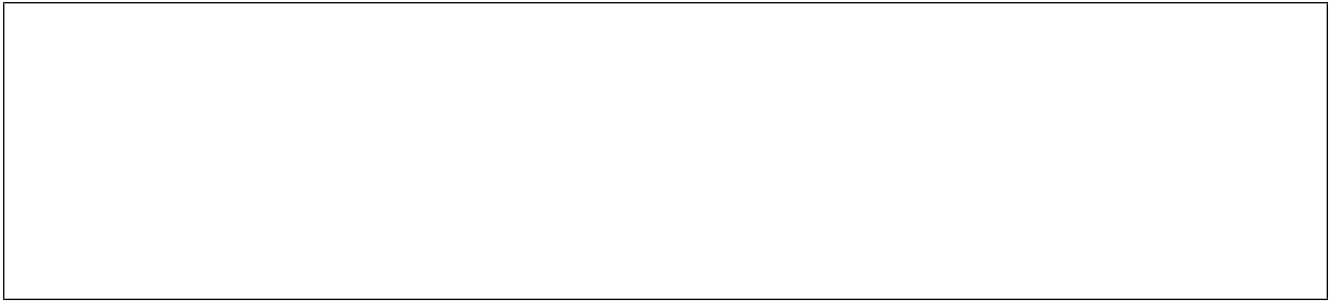
TCM for the site is Mr Phillip HOPKINS, WAMITAB expiry date is 17 March 2024, Mr Phillips HOPKINS said he is booked on to do his continuing competence training.

Waste Returns submissions - The maximum total quantity of waste accepted at the site per year shall not exceed 25,000 tonnes, the latest waste return for Q3 2023 were submitted on 23/10/23. Waste code accepted: 191204 was for 3488.54 tonnes and 1055.94 tonnes were removed from the site as waste, coded as 191212, 191204 & 191202. Waste returns must be submitted to NRW quarterly, within one month of the end of each quarter. Wilfred Sumner is responsible for submitting waste returns for the site, he has completed his continuing competence training recently.

Permit compliance and breaches - No permit non-compliances were identified on this visit and thus no breaches have been scored.
