4. Details of our assessment

On 15 February 2024 an unannounced site inspection was conducted by David Ellar and Elaine Gunstone at Airfield Metals

The weather was overcast and damp, it had recently been raining. No one was present at

the site and the gates were locked so a full inspection was not possible.

Permit breaches:

A1 Specified by Permit – Cat 4; Permit Condition 4.2.2

You have been given this category 4 breach under the above condition annual waste returns have not been submitted for 2022 or 2023.

Permit condition 4.2.2 states; within one month of the end of year, the operator shall submit to NRW using the form made available for the purpose, the information specified on the form relating to the site and the waste accepted and removed from it during the previous year.

Please submit annual waste returns for 2022 and 2023.

Actions from previous visits:

During our last visit on the 25/10/22 (CAR_NRW0040599) a Cat 3 noncompliance was identified where the site ID board was missing. It was good to see a new site ID board erected and in place.

General observations:

No one was present at the site and the gates were locked so a full inspection was not possible however officers viewed the site from the perimeter and no issues could be seen. There were ELV on site but all waste appeared to be stored correctly.

The site was secure apart from a gap in the fence at the side of the site between the fence and the site office, this area should be secured to prevent ingress to the site.

Some commercial vehicles were seen stored on the site and next to the boundary, officers

were unable to identify if these vehicles were ELV or connected to waste operations at the site. The operator should consider the fate of these vehicles and if they are waste ELV then they should be taken into the site and stored in accordance with the permit. This will be addressed at our next visit.

NRW will contact operator before next visit to ensure site is open and a full inspection can take place.
