4. Details of our assessment

Natural Resources Wales officers Chloe Howard and Chris Gurney attended Three Cocks-Tregoyd House on 21/02/2024 to carry out a routine inspection on your permit for septic tank discharge under the Environmental Permitting Regulations 2016.

On the visit, a few problems were identified. Please can you address and clarify the below information:

1) General Management:

Under section 3 of your permit it states that 'adequate facilities, improved in writing by the authority, shall be provided to enable representative samples of the discharge to be safely and conveniently obtained at any time.'

On our inspection we noticed that the cover on the septic tank was broken and requires maintenance as it is currently a health and safety issue. Please could you provide the maintenance and service history of the septic tank along with a photo/email evidence that this has been addressed and is going to be fixed.

Secondly, the permit has been taken out under your name however, please could you clarify who uses the permit? it was mentioned that the farm next to Tregoyd House may also been connected. If so can you please provide details on what waste is going in,

Lastly, next to the septic tank there were 3 blue bins. Please can you confirm what their purpose is?
