4. Details of our assessment

This Compliance Assessment Report (CAR) has been issued in response to the submission of the 2023 annual monitoring returns (1 January - 31 December) by Mekatek Limited (*the operator*) for activities at Amex Park, Llansteffan Road, Johnstown, Carmarthen SA31 3NF under permit EPR-YP3937SH.

This CAR was undertaken on 22 February 2024. However, to ensure that the CCS score is attributed to the correct financial year (for billing) the date on CARS has been altered to 31 December 2023.

Annual Monitoring Returns 2023

 - (c) the performance parameters set out in schedule 4 table S4.3 using the forms specified in table S4.4 of that schedule.
