4. Details of our assessment

On Thursday the 11th of January 2024 Natural Resources Wales officers carried out a routine

unannounced site inspection. The visit was carried out by Waste Regulation Officer Ian Thomas and Waste Crime Officer Eleanor Pierce.

On arrival officers met with Martin Scarfo, one of the site owners, he explained the running of the site and that his father Michael Scarfo was still the Technically Competent Manager (TCM) for the permit. Jessica Scarfo, who has taken over the documentation and tracking waste movements in and out of the site, was on annual leave.

Officers were accompanied around the site by Martin Scarfo. Although the site was quite muddy which is usual for the time of year, the site is well contained with minimal run off. The site was relatively clear and was processing waste brought in from Knauf, this is processed and returned to Knauf. There is a shed allocated to general waste, but this has been quiet and there was minimal waste contained there.

The operation is still producing 6F2 and topsoil which is analysed and tested to determine quality.

We returned to the site office located next to the weighbridge, a selection of Waste Transfer Notes were viewed along with the relevant permit and EMS, all documentation looked to be in order.

I am pleased to report on this occasion no issues were apparent.
